ADMINISTRATOR ERIC ROBERTSON RETIRES

After 12 years of service to the Algona, Auburn and Pacific communities and 35 years of public service, VRFA Administrator Eric Robertson retired on January 1, 2019.

Eric Robertson began his public service in 1983 with the Washington State Patrol, at the age of 19. He was commissioned as a State Trooper, assigned to Enumclaw in 1985 and held several positions. In 1994, Robertson was elected to the Washington State House of Representatives, where he served two terms representing the 31st Legislative District in King and Pierce counties. Robertson was promoted to Captain at the Washington State Patrol in 1998, led the Office of Government & Media Relations and served as Commander of the Office of Professional Standards. In 2002, Robertson was appointed by President George W. Bush as the United States Marshal for the Western District of Washington, serving as the regional administrator for the Marshals Service. In 2007, Robertson was hired as the first Administrator for the VRFA. Robertson's accomplishments in that role include guiding the process to meld the Auburn and Pacific Fire Departments into a regional fire organization, bringing financial stability and sustainability, negotiating and implementing the annexation

improvements. Approved by voters in 2008, the projects included construction of a new fire station to serve the Lakeland community, a complete remodel of the South Auburn fire station, a new fire station in the newly-annexed Lea Hill neighborhood, and purchase of a ladder truck to meet the needs of the growing region.

Other hallmarks during his tenure as Administrator include improving the delivery of service to the communities of Algona, Auburn and Pacific, which facilitated the Washington Surveying and Ratings Bureau rating improvement in all three communities. Outstanding financial stewardship by the leadership team prompted a credit rating improvement by Standard & Poors, to an AA-, and allowed for the refinancing of the bond funds - creating a savings of nearly a million dollars over the term of the bonds. The VRFA is known for its strong regulatory compliance, never having received a finding during the annual audits by the Washington State Auditor's Office or its annual reviews by the Washington Cities Insurance Authority. Robertson holds "the hiring and development of an outstanding leadership team" as his paramount achievement.

VRFA BOARD APPOINTS SWEARINGEN CHIEF

to serve as Fire Chief/Administrator, effective January 1, 2019.

"Chief Swearingen brings 34 years of experience in the fire service, significant academic achievements and industry credentials. During his tenure as Deputy Chief at VRFA, he has been a proven leader with demonstrated results," said former Board Chairman and Auburn Mayor Nancy Backus. "My fellow Board Members and I look forward to working with Chief Swearingen to continue the longstanding commitment of delivering outstanding service to the people that live, work and visit our communities."

Former Administrator Robertson selected Swearingen from a nationwide field of candidates, to lead fire and EMS operations at VRFA in 2012. Swearingen began his career as a firefighter in 1984 at the Reno, Nevada Fire Department and served in a variety of supervisory and management positions before his appointment as Operations & Administration Chief, a post he held for eight years. He has been a longtime mentor to developing fire officers and has worked extensively as an assessor and subject matter expert for executive-level testing on the west coast. While at Reno, he served a stint as the Special Assistant to the City Manager, gaining a global perspective of administrative issues.

After completing high school, Swearingen joined the U.S. Army, serving four years. He served as a Russian Language Intercept Operator with a Top Secret security clearance, prior to his Honorable discharge. Swearingen is a graduate of the University of Phoenix with a Bachelor of Arts degree in Business Administration, a Master of Arts degree in Homeland Security Studies from the Naval Postgraduate School, Monterey, California and a Master's Certificate in Alternative Dispute Resolution from the University of Denver. Swearingen is active in the greater Auburn community, serving as a board member for both Auburn Kiwanis and Nexus Youth & Family Services. A Hookstown, Pennsylvania native, Swearingen is the father of four adult children and lives with his wife Lori in Ravensdale.



We encourage you to learn CPR and first aid. By knowing CPR you may end up saving the life of someone you care about. We offer a CPR class the first Wednesday of each month and a CPR/First Aid class the third Saturday of each month. For more information visit the VRFA website at **www.vrfa.org**.

Often with high blood pressure there are no noticeable warning signs or symptoms until other serious problems arise such as heart disease and stroke. Anyone, even children, can develop high blood pressure. The good news is that high blood pressure is easy to detect and can be controlled through lifestyle changes such as increased physical activity, dietary changes and sometimes medication.

WHERE CAN YOU GET FREE BLOOD PRESSURE SCREENINGS?

We offer free blood pressure screenings at all five of our stations. VRFA stations are staffed 24 hours a day, seven days a week. Firefighters, when in the station, are available to do blood

We recently developed and implemented our Operating Budget for 2019. I am pleased to report that the administration proposed, and the Board approved, a budget which achieved our goal of meeting needs of our communities in the most cost effective manner. With inflation taken into consideration, we are funded at roughly the same level as the year prior.

I am pleased to report the VRFA's annual independent financial and accountability audit, performed by the Washington State Auditor, produced a report free of findings – the eleventh consecutive! The audit reviewed our financial statements and found that our work was compliant with state law and our own policies and procedures. We strive to be good stewards of your dollars and are pleased with these reports, which you can review by visiting our website – www.vrfa.org.

It has been a privilege to work with the men and women of the VRFA for nearly 12 years, creating the first regional fire authority in Washington state. Because of that collective work, we have established a model that others have replicated. As they say – "all good things must come to an end!" I announced back in October that I would be retiring, after over 35 years of public service, on January 1, 2019.

As one does, I have reflected on all that has been accomplished by our team since 2007,

COMMUNITY MEDICAL TEAM SEES SUCCESS IN THE FIRST THREE YEARS

Since its inception in 2016, the Community Medical Team (CMT) has consistently shown positive results, reducing the impacts on emergency response units and providing more specific care to residents in South King County. A significant change was noticed this past year when a full time social worker was added to the existing team of two full time firefighters, one from the Valley Regional Fire Authority (VRFA) and one from South King Fire

including in home care, moving him to another facility and any other viable solution. They worked with both local and county agencies but ran into a dead end with each option. They then turned their focus to the man's sister in Florida (who happens to be a nurse]. With no funding for travel, the team had to think "outside the box." In early October, with funding from South King Fire & Rescue, the man was assisted by the Community Medical Team with a ride to the airport, an escort through security and was helped directly on to a plane. Prior to assisting him at the airport, the team boxed his personal items and shipped them to Florida. They also helped him shower and prepare for the trip. He reached Florida safely and the team has followed up with his sister on several occasions. He seems to be doing much better in Florida. This is just one success story among many.

The CMT program is an emerging healthcare delivery model that assists patients with chronic health issues outside of the hospital setting. This more comprehensive approach is having a dramatic impact on the diversion of calls away from emergency units and has improved the quality of life for many of our community members. For example, in 2018 the team attempted to assist an older gentleman that had a series of strokes and had just returned from a skilled nursing facility. His insurance had run out. He was discharged and sent home from the care facility. While at home he began falling and calling 9-1-1. With no support network locally, the gentleman placed 15 calls to 9-1-1 over a 60-day period. The team looked at many options during that 60 day time period,
