MINUTES

I. CALL TO ORDER

Chair Leanne Guier called the Valley Regional Fire Authority (VRFA) Board of Governance Regular Board Meeting to order at 5:55 p.m., via Videoconference.

Chief Swearingen updated members on the COVID testing site at GSA location. He stated firefighters from VRFA are working the site.

Chief Swearingen stated the Entry Level Firefighter Oral Board process just finished up and the VRFA invited 70 candidates to interview via a remote site setup at St. 33 and St. 31.

Chief Swearingen updated members on the status of the Captains Tactical test that was taking place this week at SKCFTC.

Chief Swearingen started the conversation around changing the date and time of Board meetings followed by CFO Horaski speaking on the affects having the meetings so early in the month has on Accounts Payable.

A. Resolution No. 162 – 2020 Budget Amendment

CFO Horaski stated that the budget amendment was due to our obligation to out vendor to pay for repairs to a VRFA engine that was hit while responding to a call on Highway 167. . Horaski stated the insurer issued proceeds directly to VRFA rather than the vendor that performed the repairs. Because the amount of the repair exceeds the Fire Chief's spending authority, this amendment allows us to pay the repair bill.

There being no further questions or discussion, Member Backus moved and Member DaCorsi seconded to approve.

B. MVF&R Collective Service Agreement

Chief Swearingen stated this agreement was for fire prevention services with Mountain View Fire and Rescue and allows for the VRFA to perform fire services for MVFR whit they find and train fire prevention personnel within

their own organization. He indicated this contract is explicit that fire prevention duties in the VRFA service area will take precedence over any work done under contract with MVFR.

There being no further questions or discussion, Vice Chair Hill moved and Member Backus seconded to approve.
