GOVERNANCE BOARD MEETING MINUTES

I. CALL TO ORDER

Vice Chair Nancy Backus called the Valley Regional Fire Authority (VRFA) Board of Governance Regular Meeting to order at 5:45 p.m.

B. Roll Call

Staff members present included Chief Brad Thompson, Deputy Chief Dave Larberg, Deputy Chief Rick Olson, CFO Mark Horaski, Legal Counsel Eric Quinn, and Clerk of the Board Stefanie Harper.

Chief Thompson presented Member DaCorsi with a retirement plaque. Member DaCorsi has served 6 years on the VRFA Board of Governance. Chief Thompson expressed his gratitude for his service and dedication to the communities we serve.

A. Administration

Chief Thompson provided an update to the Board on the overall call volume for 2021 – he stated we are currently 15.5% over our call volume from 2020.

Chief Thompson provided an update on the Fire Pilot program we are taking part in through L&I, which will lead to lower Worker Comp rates.

Chief Thompson provided an update on the Entry Level Firefighter process and indicated we have five individuals currently going through the background process and are set to start the February 2022 academy. Furthermore, we have five recruits who are in the EMT portion of the 2021 academy and are set to graduate in January 2021 and will be assigned shifts on January 20th.

Chief Thompson stated the Captains test is taking place in March.

Chief Thompson updated the Board that we have five internal candidates who have applied for the UW Foster School of Business Emerging Leaders Academy.

Chief Thompson stated tomorrow is our final stage of the Accreditation process. This final hearing will take place virtually and we are confident we will pass this final stage and be granted accreditation status.

C. 2022-2024 Battalion Chief/Fire Marshal CBA

Vice Chair Backus convened the closed session at 6:02 pm with the Board members. The closed session concluded at 6:07 pm and the Board returned to their regular meeting.

There being no further discussion or questions, Member Guier moved and Member Storaasli seconded the approval of the 2022-2024 Battalion Chief/Fire Marshal CBA.

D. Resolution No. 177: Indemnification

CFO Horaski stated Resolution 177 is providing a defense and indemnification to Chief Thompson, by his employer, Valley Regional Fire Authority in litigation arising out of a current lawsuit. Chief Brad Thompson is named as a defendant, in which VRFA is also a party. Chief Thompson was taking actions as Fire Chief on behalf of Valley Regional Fire Authority.

There being no further discussion or questions, Member Guier moved and Member Dacorsi seconded the approval of Resolution No. 177.
