Expressed gratitude to the City of Auburn for allowing us to participate in the Veteran's Day Parade. Despite the storm the night before, VRFA successfully displayed the new ladder and flag, and we're thankful for the opportunity.

Currently, the November 7th election is passing, but we're awaiting certification. A big thank you to our members for their support, with special acknowledgment of IAFF 1352's extra hours supporting Prop 1.

Kimberly Terhune has accepted and will be transitioning to the new role of Emergency Management Coordinator after 32 years in Public Information.

We currently have two open positions: an IT Systems role and a Community Outreach Specialist. Both are in the initial review stage, with interviews scheduled for late November and early December.

Eight VRFA recruits are concluding the fire side of the academy and moving to EMT in the next month. We have one candidate who is undergoing a background process for the February academy.

Scout Night is on November 15th at St. 33 and will include activities and safety lessons for our community's Scouts. This is always a well-attended event.

VRFA FF and EMTs are taking part in an ongoing study by KC EMS and UW focusing on the First Responders' Airway and Compression Trial, (FACT) evaluating the effectiveness of ventilation techniques and compression rates.
